Important Notes for cargo to Viet Nam :

- 1. Our Taxcode : 0302034333 must be shown on MBL or MAWB as Vietnamese Law.**
2. For Dangerous goods : Please check with us before shipping .
3. Pre-alert should be sent to us at least 3 office hours before the flight arrive for air freight and 24 hours before ETA for sea freight for manifest submitting . Any adjustment or supplementary (any document) after the flight / vessel arrive will be against the amendment manifest of USD 545 per case in Ho Chi Minh City & Ha Noi ; 575 USD per case in Cai Mep Terminal ; 545 usd per case for Hai Phong , Da Nang shipment ; 650 usd per case for Cai Lan shipment .
The charge is included our handling and the penalty for any wrong or late manisest as 10,000,000 VND (450 USD) , following Decree 128/2020/NĐ-CP , date 19 Oct 2020 .
4. With Air shipment please make sure all cartons have House Label . The fine for lack of House Label is 5 USD / Carton, min 45 USD / shipment .
